



## GapCross Release Notes

### Release 3.08.0823 August 23, 2022

- Small change to the description field of default programs included in new accounts.
- Enabled feature to allow authors to share their published programs with other users. This feature requires the sharing/collaboration capability.

### Release 3.07.0430 April 30, 2022

- Added a single question mode. Single mode is the default, with a button to switch between the "single" and "all" display modes.
- Fixed client information display to not overrun the display area.
- The left section navigation panel to adjust with screen size.
- Added ability to collapse/hide the section navigation panel.
- Improved the assessment sharing process.
- Enhanced the new user getting started experience.
- The assessment "modify" menu action is now a button on the main display and is renamed to "Open".
- Changed the report so that informational questions that don't involve an answer do not display "no answer" in the narrow rightmost column of the report..
- When signing in, the email address entered is displayed on the resulting message so that the user can see if they entered their email correctly.
- Added feature for users to change their email address
- Renamed the "reset" all questions button to "clear all" and requires the user to enter "clear" to confirm. The individual question reset button is still called reset.
- Fixed minor bugs and typographical errors

- Change "add attachment" so that additional attachments can be selected while others are uploading.

- Eight small bug fixes.
- Added ability for authors to add labels to questions for future report functionality

- As mentioned above, create and manage to-do tasks to ensure a process is fully and accurately completed.
- Reporting for management oversight of production process activities

### Program Authoring

- Improved dashboard display
- Ability to instantly see how program changes look on an assessment and in a report.
- Ability to develop operating procedure applications by simultaneously using and revising the procedure until it is ready to become an approved configuration controlled SOP.

Improved the user experience for first-time users

- If a user responds to a link on an email or landing page they enter GapCross on the marketplace application they are expecting to see.
- After "getting" an application the application can be started without changing dashboards
- Rearranged the elements on the Home dashboard
- Changed "Assess" button to "Start" on all applicable dashboards
- Changed the sequence of selection on the Start assessment popup to improve the flow and make the required field more intuitive to use
- If there are no clients the client selection fields are hidden on the start assessment popup
- Changed the name on the Get Started button to Tutorial
- Added a question mark "?" icon on all of the dashboards that opens the tutorial
- The terms of service and privacy policy are shown on the Profile dashboard.
- Allow special characters in the name of a client
